

ROCKETRY ORGANIZATION OF CALIFORNIA
VENDOR AGREEMENT AND RELEASE AND WAIVER FROM LIABILITY

Please read carefully! This is a legal document which affects your legal rights!

This Release and Waiver of Liability executed at Lucerne Valley, California this _____ day of _____, 20____ by _____ (Hereinafter the "Vendor") in favor of Rocketry Organization of California, United States Department of the Interior – Bureau of Land Management, National Association of Rocketry, Tripoli Rocketry Association, all other approved onsite vendors, officers, members, and volunteers (collectively "ROC"). This agreement remains in effect from the day of signature for one full year.

Rocketry is an inherently dangerous activity. Rules and procedures have been created to help make this activity as safe as possible. Everyone attending ROC events is participating at their own risk and is responsible for following the rules and regulations of Rocketry Organization of California , National Association of Rocketry (NAR), and Tripoli Rocketry Association (TRA).

I acknowledge that as a Vendor, I must not operate within the active portions of the range and must confine business activities to the parking, camping, and spectating areas (excluding safety lanes and zones). ROC will accept requests for front row parking if received one week prior to the scheduled activity, however, ROC cannot guarantee vendor placement within the launch site.

In consideration of being permitted to conduct business at ROC launches, the Vendor understands, and does hereby freely, voluntarily, and without duress execute this Release and Waiver under the following terms:

1. Agree to indemnify and hold harmless ROC from all claims, demands, liabilities, damages, costs and expenses that the Vendor may now or hereafter have against them resulting from my participation in ROC activities. This release applies not only to the Vendor but also to my employees, heirs and assigns.
2. Assume all of the risks, including property damage, injury, illness or even death and agree to follow the safety code, rules, and regulations of ROC, NAR, and TRA. Vendor recognizes and understands that participation in rocketry involves inherently dangerous activities.
3. Understand that ROC cannot be held responsible for the failure of other participants to abide by the safety code and rules and regulations of ROC, NAR, or TRA.
4. Certify that the Vendor has the necessary certification, experience, and training if operating high-power rockets.
5. Certify that the Vendor has the necessary Federal, State, and County permits and licenses to conduct business at Lucerne Dry Lake, San Bernardino County, California (on Federally managed lands).
6. Expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the state of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
